Chapter 600. Alcoholic Beverages

Section 600.040. Schedule of License Fees.

- A. The following categories and subcategories of licenses shall be issued upon compliance with the provisions of this Chapter and payment of the license fee indicated:
 - General licenses.
 - a. Malt liquor original package: \$75.00.
 - b. Intoxicating liquor (all kinds) original package: \$150.00.
 - c. Malt liquor by drink: \$75.00.
 - d. Malt liquor and light wines by drink: \$75.00.
 - e. Intoxicating liquor (all kinds) by drink: \$450.00.
 - 2. Sunday sales (additional fee).
 - a. Intoxicating liquor at retail: \$300.00.
 - 3. Permits.
 - Temporary permit by the drink for certain organizations (7 days max.): \$37.50.
 - b. Tasting permit: \$37.50.
 - c. Caterers: \$15.00 per each calendar day.

Of the license fee to be paid for any such license, the applicant shall pay as many twelfths (12ths) as there are months (part of a month counted as a month) remaining from the date of the license to the next succeeding July first (1st).
