AN ORDINANCE AMENDING THE POLICE SERVICE AGREEMENT BETWEEN ST. LOUIS COUNTY AND THE CITY OF VALLEY PARK

WHEREAS, St. Louis County and the City of Valley Park entered into Police Service Agreement on the 17th day of June, 2017 with an expiration date of June 30, 2022, wherein contingencies for ancillary amendment provisions are outlined in paragraph 6; and

WHEREAS, the provisions of Section 70.210 to 70.320 R.S. Mo. 2000, as amended, empower municipalities and other political subdivisions to contract and cooperate with each other for a common service; and

WHEREAS, the City of Valley Park desires the continued enforcement of the Ordinances, and police protection and services, including local patrols and traffic supervision: and

WHEREAS, the City of Valley Park has duly enacted and approved Ordinance No. 1980, a copy of which is attached hereto and made a part hereof, authorizing the Mayor and Board of Aldermen to execute this Agreement;

NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF ALDERMEN OF THE CITY OF VALLEY PARK, MISSOURI AS FOLLOWS:

Paragraph (3)A of the Police Service Agreement is deleted and the following Paragraph (3)A is substituted in lieu thereof as follows:

(3)A Patrol Service - To include seven (7) days per week, twenty-four (24) hours per day regular motorized patrol, responding to radio directed assignments, car checks, enforcement of moving traffic violations, driving while intoxicated arrests, follow-up investigations of certain larcenies, auto thefts and other uniform police functions. In addition, St. Louis County shall provide one uniform police officer one night each month for the purpose of providing security at the municipal court of the City of Valley Park. All services performed under this Agreement shall be at a minimum set out in Exhibit A which is attached hereto and made part of this Agreement. St. Louis County shall provide thirteen (13) police officers from the St. Louis County Police Department, and one (1) officer with the rank of Lieutenant who will command the assigned officers. Said officers shall cooperate with the City of Valley Park in the performance of their duties and shall serve as police officers of the City of Valley Park but shall be subject to the supervision of the St. Louis County recognized chain of command. On January 1, 2018, St. Louis County shall add one (1) more police officer from the St. Louis County Police Department, having fourteen (14) police officers providing service to the City of Valley Park. Effective July 1, 2019, St. Louis County shall add an additional two (2) police officers for Court security, having three (3) police officers providing Court security and Protection once a month.

Paragraph (9) of the Police Services Agreement is deleted and the following Paragraph (9) is substituted in lieu thereof as follows:

(9) The contract rate for the second renewal term will be ONE MILLION FIVE HUNDRED TWENTY-EIGHT THOUSAND EIGHT HUNDRED SIXTY-FOUR DOLLARS AND SIXTY-EIGHT CENTS (\$1,528,864.68) or ONE HUNDRED TWENTY-SEVEN

THOUSAND FOUR HUNDRED FIVE DOLLARS AND THIRTY-NINE CENTS (\$127,405.39) per month.

After the second renewal term of the Agreement is completed, St. Louis County may adjust the cost of the Agreement by providing the City of Valley Park written notice at least thirty (30) days prior to the expiration of the first year or any subsequent year or renewal term of the Agreement to reflect any annual increase or decrease in St. Louis County's personnel and support service costs and the notice shall be in the form of a "Police Service Costs" sheet similar to the form attached hereto and marked Exhibit A. For the purpose of calculating the overall annual compensation adjustment for the Agreement, no increase in costs shall exceed five percent (5%) of the costs for the preceding year.

Except as expressly modified by terms of this First Amendment to the Police Service Agreement, and all of the terms, covenants and conditions of the original Police Service Agreement shall remain in full force and effect and are hereby ratified and affirmed.

This Ordinance shall become effective from and after its passage and approval by the Mayor.
