ORDINANCE NO. 2044

AN ORDINANCE AMENDING SCHEDULE I AS IT RELATES TO
THE TRAFFIC CODE PERTAINING TO SPEED LIMITS BY ADDING TWO NEW
SPEED LIMIT SIGNS AT MERAMEC STATION ROAD FROM SMIZER MILL
ROAD TO HILLSBORO ROAD AND HILLSBORO ROAD IN ITS ENTIRETY
INSIDE VALLEY PARK CITY LIMITS TO THE LIST OF SPEED LIMITS

WHEREAS, the Board of Aldermen of the City of Valley Park has received a request for consideration for the installation of speed limit signs on Meramec Road at Smizer Mill Road to Hillsboro Road and speed limit signs on Hillsboro Road in its entirety within Valley Park City limits,

WHEREAS, documentary and testimonial evidence has been presented to the Board of Aldermen demonstrating the health and safety issues present on the aforementioned roads,

WHEREAS, the Board of Aldermen desire to restrict speed limits to 20 miles per hour in an effort to prevent accidents involving automobiles and/or pedestrians,

WHEREAS, the Board of Aldermen of the City of Valley Park wish to amend Schedule I to the Traffic Code pertaining to speed limits within the city limits,

NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF ALDERMAN OF THE CITY OF VALLEY PARK, MISSOURI AS FOLLOWS:

Section One

Schedule I is hereby AMENDED and the following language added to "Location" and the respective "Speed Limit":


Schedule I, Speed Limits	
Location	Speed Limit
<u>Meramac Station Road (between Smizer Mill Road to Hillsboro Road)</u>	<u>20 mph</u>
<u>Hillsboro Road (within City limits)</u>	<u>20 mph</u>

Section Two

The Director of Public Works is hereby directed to order and install speed limit signs at the aforementioned locations within a reasonable time after passage and approval of this ordinance.

This Ordinance shall become effective from and after its passage and approval by the Mayor.
