NEW BUSINESS

Mayor Webster stated that comments made during the Special Board of Aldermen meeting from June 29th indicated Bill No. 2023-07 adopting the FY23/24 budget, Bill No. 2023-08 adopting the FY23/24 pay ranges, and Bill No. 2023-09 reaffirming the gross receipts tax had passed. This was incorrect and these bills had not passed.
