Alderman Walker made a motion to excused Alderman White from the meeting, seconded by Alderwoman Halker. **Motion carried** with 6 ayes.

## MINUTES

January 22, 2019 Board Meeting minutes – A motion was made by Alderwoman Halker to approve the minutes as written, seconded by Alderwoman Reynolds. **Motion carried** with 6 ayes.

Alderman Walker stated that the last Legislative Committee Minutes would be ready for approval at the next Board meeting.

## NEW BUSINESS

**Dougherty Ferry Road Project Bid:** Alderman Walker made the motion to accept the \$414,414.14 bid from Sweetens Concrete with the condition that they are in good standing with Cochran Engineering, seconded by Alderman Young. **Motion carried** with 6 ayes.

Valley Park Athletic Association Liquor License Renewal: Alderman Drake made the motion to approve the liquor license renewal for the Valley Park Athletic Association Liquor License and waive the renewal fee, seconded by Alderwoman Reynolds. Motion carried with 6 ayes.

**ECode 360 Update Quote (General Codes):** Alderman Walker made the motion to table this until the next Board meeting because Bill 2208/Ordinance 2026 – Fee Structure Ordinance needs to be amended, seconded by Alderwoman Reynolds. **Motion carried** with 6 ayes

Bill 2209/Ordinance 2027 – Amending Zoning Appendix A (Marijuana Dispensaries & Growers): An Ordinance amending the Zoning Appendix A to include Marijuana Dispensaries & Growers requirements to the zoning ordinance.

Alderman Walker made a motion to put the bill on its first reading by title only. Alderwoman Reynolds seconded the motion. Motion carried with 6 ayes.

Alderwoman Reynolds made a motion to put Bill 2208 on its second and final reading by title only, seconded by Alderwoman Halker. **Motion carried** with 6 ayes.

Alderman Walker made a motion to approve Bill 2208, seconded by Alderwoman Reynolds. On a roll call vote, the bill was placed as an ordinance as followed:

Alderman Walker asked if the park is being used again this year for the mountain bike. Mr. DeNormandie told Alderman Walker that the park is going be used for the race.

Alderman Young asked if the issues with the Firehouse software been resolved.
