Bill 2224 – An Ordinance Creating Section 520.015 Regarding Construction of Parking Surfaces, Drainage and Maintenance

Alderman Walker made a motion to put Bill 2225 on its first reading by title only. Alderwoman Reynolds seconded the motion. **Motion carried** with 7 ayes.

Alderman Walker made a motion to put Bill 2225 on its second and final reading by title only. Alderwoman Reynolds seconded the motion. **Motion carried** with 7 ayes.

Alderman Walker made a motion to approve Bill 2225, seconded by Alderwoman Reynolds. **Motion carried** with 7 ayes. **Bill 2225 then became Ordinance No. 2043.**

Bill 2226 – Salary Ordinance

City Clerk Dusty Hosna explained that this Bill is no longer relevant.

Alderman Walker made a motion to table Bill 2226, seconded by Alderwoman Reynolds. **Motion carried** with 7 ayes.

Alderwoman Reynolds made a motion, seconded by Alderman Walker, to proceed with placing signage at Dougherty Ferry and Forest Avenue that listed "No Thru Truck Traffic." **Motion carried** with 7 ayes.
