#### **NEW BUSINESS**

### Bill 2238 - A Conditional Use Permit for 839 Meramec Station Road

Mayor Webster read Bill 2238 by title only.

Alderman Bowen abstained from voting and discussion.

Discussion was held on the subdivision that was part of the ordinance and the safety of emergency vehicles exiting the property.

Alderman Walker made a motion to put Bill 2238 on its first reading by title only with a question. Alderman White seconded the motion. Alderman Walker asked that a roll call be conducted for each vote. Discussion was held. Motion carried with 7 ayes – Alderman Bowen abstained. Motion passed.

Alderman Walker made a motion to put Bill 2238 on its second and final reading by title only. Alderman White seconded the motion. Motion carried with 7 ayes – Alderman Bowen abstained. Motion passed.

Alderwoman Halker made a motion to approve Bill 2238, seconded by Alderman Walker. Motion carried with 7 ayes – Alderman Bowen abstained. **Motion passed**. Bill 2238 then became Ordinance No. 2053.

### Bill 2239 - Agreement for STP Phase 3

City Clerk Dusty Hosna explained that this bill is part of the St. Louis Avenue STP Phase 3 approval.

Alderman Walker made a motion to put Bill 2239 on its first reading by title only. Alderman White seconded the motion. Motion carried with 8 ayes.

Alderwoman Reynolds made a motion to put Bill 2239 on its second and final reading by title only. Alderman Walker seconded the motion. Motion carried with 8 ayes.

Alderwoman Reynolds made a motion to approve Bill 2236, seconded by Alderman Walker. **Motion carried** with 8 ayes. Bill 2239 then became Ordinance No. 2054.
