Requirements:

1. Dumpsters must be equipped with a cover so that when not in use, the container will not accumulate significant amounts of water so as to cause leakage.
2. Liquid leachate must not leak from the container onto any street, sidewalk or public right-of-way.
3. The name of the company responsible for placement and removal of Portable Storage Containers, Trailers, Pods and Dumpsters must be displayed on same as well as the Portable Storage Containers, Trailers, Pods and Dumpsters tag.
4. At no time will Portable Storage Containers, Trailers, Pods and Dumpsters be placed onto any running lane of the roadway, restricting the flow of traffic.
5. The Portable Storage Containers, Trailers, Pods and Dumpsters may be placed on or near the above-identified property in the location set forth herein. Only refuse from the above-identified property shall be placed in the dumpster.
6. Such permit shall specify the dates of commencement and cessation of the proposed placement, not to exceed fourteen (14) days for Storage Trailers, PODS or similar devices and thirty (30) days for Dumpsters or Construction Trailers.
7. No more than three (3) permits may be issued in any twelve (12) month period for the same property. The permit shall allow only one (1) device per lot, and the dimensions of said device shall not exceed sixteen (16) feet by eight (8) feet by eight (8) feet (i.e. 16' x 8' x 8').
8. The City of Valley Park Portable Storage Containers, Trailers, Pods and Dumpsters may cause to have it removed from its location, at the permit holder's expense, if either (a) this Portable Storage Containers, Trailers, Pods and Dumpsters permit or extension thereof is not in affect, or (b) the Portable Storage Containers, Trailers, Pods and Dumpsters is at a location other than the above-identified property.

PERMIT MUST BE ATTACHED TO THE CONTAINER AND VISIBLE FROM THE STREET
