# Finance Ways and Means Committee Minutes April 6, 2021

At 6:31 P.M. the meeting was called to order and all in attendance recited the Pledge of Allegiance.

Committee members in attendance were Alderman Young, Alderman Rose, Alderman Halker and Alderman White.

Mayor Webster, Alderman Rauls, Alderman Walker, Alderman Reynolds were also in attendance.

Dusty Hosna, Tim Engelmeyer, Gerald Martin, Gil DeNormandie, and Rose Legrand were also in attendance.

The City Administrator Dusty Hosna did a recap of the City of Valley Park FY2020/2021 budget.

The City of Valley Park received \$359,195.14 from the Corps of Engineers from the Meramec River Levee fund. Alderman White made a motion to place in a separate line item for future levee expenses and invest the money in an interest-bearing account. with Meramec Valley Bank.

Alderman Rose seconded. All in favor, motion carried.

The City of Valley Park received \$487,234 from St. Louis County for Covid. Alderman White made a motion to put this amount towards the St. Louis County Police Contract. Alderman Halker seconded. All in favor, motion carried.

The City Administrator presented a need for a new vehicle for Code Enforcement/ Building Inspections. Alderman Young made a motion to approve up to \$5000 a year for five years for the purchase of a new vehicle by the City Administrator. Alderman White seconded. All in favor, motion carried.

The City Administrator presented to the FWM committee for the need to add one new employee for the Street/Sanitation dept. Alderman Young made a motion to approve one new employee for the Street/Sanitation. Alderman White Seconded. All in favor, motion carried.

The City administrator and the Parks Department recommended the FWM committee approved money for the concrete at the ball fields be reallocated to install turf mix and laser align the infields. Alderman Young made a motion to install the turf mix and laser

align the infields and to poll the board for approval and provide the final amount. Alderman White seconded. 3 to 1, motion Carried. Alderman Young Yes, Alderman White Yes, Alderman Rose No.

### 05-03-2021 Board of Aldermen Special Session Meeting Minutes

A motion was made by Alderwoman Reynolds, seconded by Alderman Walker, to approve the 05-03-2021 Board of Aldermen Regular Session Meeting Minutes. **Motion passed** with 8 ayes.

### 04-08-21 Legislative Committee Meeting Minutes

A motion was made by Alderman Walker, seconded by Alderman White, to approve the 04-08-2021 Legislative Committee Meeting Minutes. **Motion passed** with 8 ayes.

### PUBLIC COMMENT SECTION

Scott Rue – 76 Inez Ave – Mr. Rue addressed concerns with the St. Louis Avene road project and asked that the board consider a smaller sidewalk in front of the residential units in the 500 block of St. Louis Avenue.

It was discussed that this item will be added to an Enhancement - Community Development agenda.

### PLAYGROUND BIDS - BRIGNOLE PARK

Parks Director Gil DeNormandie explained that the city received municipal parks grant to update the Brignole Center Park and Building. A bid opening was held for the upgrades to Brignole Park playground. Mr. DeNormandie presented those results to the Board of Aldermen.

A motion was made by Alderman Walker, seconded by Alderwoman Halker, to accept the low bid from Playground Equipment Professionals. **Motion passed with 8 ayes.** 

### PARKING SCHEDULE AMENDMENTS

The following recommendations were made to the Board of Alderman from the Legislative Committee:

### Discussion of Quinwood Avenue Parking - April 8, 2021- Legislative Committee

Residents of Quinwood presented a petition requesting revising no parking on both sides of road. After brief discussion a motion was made by Mike White to recommend amending the parking schedule for Quinwood to reflect no parking on both sides of the road from intersection of Jefferson to eastern end of lot 152 on south side and eastern end ot lot151 on the north side and no parking only on south side of Quinwood to cul de sac. 2nd by Jon Young. Motion passed. Recommendation to be forwarded to Board of Aldermen for passage.

Discussion of St. Louis Avenue Parking Ordinance Schedule – May 3, 2021 – Legislative Comittee
Discussion of confusing and redundant wording in the existing ordinance. Jon Young made a motion to amend the ordinance to require no parking on both sides of St. Louis Avenue from Beckett Memorial Drive to the levee gate. 2<sup>nd</sup> by Mike White. Motion passed.

A motion was made by Alderwoman Halker, seconded to Alderman Walker, to amend the parking ordinance as requested by the Legislative Committee. **Motion passed** with 8 ayes.

### APRIL BILLS

A motion was made by Alderman Walker, seconded by Alderman White, to approve payment of the April bills. **Motion** passed with 8 ayes.

Public Works Director Gerald Martin gave a brief report and gave an update on the St. Louis Avenue project.

Community Development Director Gil DeNormandie gave a brief report. He discussed the progress at the Meramec Rec Plex.

Lt. Noonan presented the March Police Report.

AN ORDINANCE GRANTING A CONDITIONAL USE PERMIT AND ZONING CHANGE TO LDSD, LLC TO ALLOW AN EXPANSION OF A PLUMBING BUSINESS ON A CERTAIN TRACT OF LAND AT 303 BENTON STREET & 300, 306, 312, 314 & 318 ST. LOUIS AVENUE WITHIN THE CITY OF VALLEY PARK, MISSOURI

WHEREAS, LDSD LLC filed for a Conditional Use Permit on May 24, 2021, to expand a plumbing business from 306 St. Louis Avenue within the City of Valley Park, Missouri to 303 Benton Street & 300, 306, 312, 314 & 318 St. Louis Avenue; and

WHEREAS, LDSD LLC filed for a Rezoning request on May 24, 2021 for a property located at 303 Benton Street within the City of Valley Park, Missouri, requesting a change from "R-2 Residence" to "C-1 Neighborhood Business"; and

WHEREAS, in accordance with Article X, Section 405.610 Conditional Use Permit Procedure and Article XII, Section 405.720 Hearings Before Public Bodies, public notice has been given for the request for the Conditional Use Permit and Rezoning request through: 1) the publication of a Public Hearing advertisement in a paper of general circulation, 2) the notification of adjacent property owners, and 3) the posting of a sign on the subject property; and

WHEREAS, a Public Hearing was held on May 24, 2021, by the Planning and Zoning Commission regarding the request by LDSD LLC for the Conditional Use Permit and Rezoning request; and

WHEREAS, following the Public Hearing by the Planning and Zoning Commission and after consideration of the request and testimony presented therein, the Planning and Zoning Commission finds it is in the public interest to approve the Zoning change and the Conditional Use Permit requested by LDSD LLC to allow a an expansion of a plumbing business at 303 Benton Street & 300, 306, 312, 314 & 318 St. Louis Avenue, subject to the conditions set forth herein; and

WHEREAS, the Planning and Zoning Commission submitted a report of their decision to approve the Conditional Use Permit and Rezoning request to the Board of Aldermen; and

**WHEREAS**, The Board of Aldermen of the City of Valley Park hereby adopts the Planning and Zoning Recommendation. {{{possibly ... "the BOA hereby adopts the P&Z recommendation..."}}}

NOW THEREFORE, BE IT ORDAINED BY THE BOARD OF ALDERMEN OF THE CITY OF VALLEY PARK, MISSOURI AS FOLLOWS:

### Section One

Pursuant to the provisions of Article XII Amendments, of the Valley Park City Code, the Board of Aldermen hereby approves a rezoning request to allow for a change from "R-2 Residence" to "C-1 Neighborhood Business" subject to the provisions of the city code.

### Section Two

Pursuant to the provisions of Article X, Section 405.610 Conditional Use Permit Procedure, of Title IV Land Use, of the Valley Park City Code, the Board of Aldermen hereby approves a Conditional Use Permit to

LDSD LLC to expand existing plumbing business as laid out in their application subject to the provisions of the City Code and the following Conditions:

- 1. The property shall be maintained substantially in accordance with the site plan filed with the City. Any changes to the site layout or storage areas shall be submitted to the City for approval prior to construction of such changes.
- 2. All materials stored in the fenced area shall be stacked no higher than the fence, so not visible above the fence line from the street or from adjacent property.
- 3. A minimum of thirteen (13) publicly accessible parking spaces shall be provided on-site.
- 4. All bioretention areas shall be maintained with vegetation of grass and or plantings.
- 5. Hours of operation shall be Monday through Friday from 5:00am till 6:00pm. The business may also operate as necessary to provide emergency services.
- 6. All fencing and gates must be maintained in good condition.
- 7. The property shall be maintained and operated so as not to cause any offenses pursuant to Chapter 210 or any nuisances pursuant to Chapter 215.
- 8. The owner shall provide the City with documentation from the Metropolitan St. Louis Sewer District outlining any requirements for water quality and/or quantity mitigation for the development.
- 9. Access drives along Benton Street shall be left-out only for truck traffic. Trucks shall not go east on Benton Street from the property.
- 10. Vehicle traffic to and from the site after hours and for emergency use shall only use the St. Louis Avenue site access drives.
- 11. Inspections by the City shall be allowed during normal hours of operation or as otherwise necessary to allow the City to confirm conformance with this Conditional Use Permit.
- 12. This Conditional Use Permit shall lapse and become void if for any reason the business ceases operation for a period of one (1) year or more.
- 13. This Conditional Use Permit shall not be assigned, sold, conveyed, or operated by another party or entity without prior approval according to the provisions of Article X, Section 405.610.I.

### Section Three

In acting upon this application, the Board of Aldermen has accepted into the record the Ordinances of the City of Valley Park, Missouri, the Comprehensive Plan for the City of Valley Park, Missouri, and the Conditional Use Permit Application, Rezoning Request Application, and other records submitted by the applicant or gathered by the City relative to said application.

### Section Four

This Ordinance shall become effective from and after its passage and approval by the Mayor.

AN ORDINANCE GRANTING A CONDITIONAL USE PERMIT FOR THE PURPOSE OF A PERSONAL FIREARMS SAFETY TRAINING AND SUPPLY BUSINESS ON A CERTAIN TRACT OF LAND LOCATED AT 232 VANCE ROAD SUITE 104-G VANCE ROAD WITHIN THE CITY OF VALLEY PARK, MISSOURI

WHEREAS, Jacob Peterson filed for a Conditional Use Permit on April 23, 2021, to allow for the establishment of a personal firearms safety training and supply business at 232 Vance Road SUITE 104-G within the City of Valley Park; and

WHEREAS, in accordance with Article X, Section 405.610 Conditional Use Permit Procedure and Article XII, Section 405.720 Hearings Before Public Bodies, public notice has been given for the request for the Conditional Use Permit through: 1) the publication of a Public Hearing advertisement in a paper of general circulation, 2) the notification of adjacent property owners, and 3) the posting of a sign on the subject property; and

WHEREAS, a Public Hearing was held on June 14, 2021, by the Planning and Zoning Commission regarding the request by Jacob Peterson for the Conditional Use Permit; and

WHEREAS, following the Public Hearing by the Planning and Zoning Commission and after consideration of the request and testimony presented therein, the Planning and Zoning Commission finds it is in the public interest to approve the Conditional Use Permit requested by Jacob Peterson to allow a personal firearms safety training and supply business at 232 Vance Road SUITE 104-G, subject to the conditions set forth herein; and

WHEREAS, the Planning and Zoning Commission submitted a report of their decision to approve the Conditional Use Permit and Rezoning request to the Board of Aldermen which is adopted and incorporated herein; and

WHEREAS, upon review of the Planning and Zoning Commission decision report, the Board of Aldermen adopts said decision.

NOW THEREFORE, BE IT ORDAINED BY THE BOARD OF ALDERMEN OF THE CITY OF VALLEY PARK, MISSOURI AS FOLLOWS:

### Section One

Pursuant to the provisions of Article X, Section 405.610 Conditional Use Permit Procedure, of Title IV Land Use, of the Valley Park City Code, the Board of Aldermen hereby approves a Conditional Use Permit to Jacob Peterson to allow a personal firearms safety training and supply business at 232 Vance Road SUITE 104-G, subject to the provisions of the City Code and following Conditions of Approval:

- 1. The business owner shall maintain a valid Federal Firearms License from the Alcohol Tobacco and Firearms Commission.
- 2. All training and sales of firearms shall be in accordance with local, state, and federal regulations and requirements.

- 3. The business shall be operated substantially in accordance with the Conditional Use Permit Application submitted to the City and on file with the City Clerk.
- 4. No use of live ammunition is permitted on the property.
- 5. The hours of operation shall be Monday through Saturday from 8:00 a.m. till 9:00 p.m. and Sunday from 9:00 a.m. till 8:00 p.m.
- 6. All security camera footage shall be monitored and maintained for at least ninety (90) days and be made available to law enforcement upon request.
- 7. A secure vault area with a locking safe shall be permanently affixed or built into the interior of the building for storage of firearms and other products.
- 8. All signage shall be installed with a proper permit and compliant with the City's Sign Regulations, Chapter 515.
- 9. Overnight class sessions may be held but must be limited to two class sessions a month with each session being no more than two consecutive nights.

SUBJECT: MONTHLY REPORT - May 2021

Police Officers assigned to the City of Valley Park responded to 456 calls from citizens during the month. May calls from citizens were up 65 calls, compared to the same month for 2020. In addition to the calls from citizens, officers assisted without being called or took action on an additional 854 calls and wrote 72 police reports.

Year-to-date statistics: There have been 2315 calls for service. There were 2484 calls for service from last year at the same time.

**Neighborhood Policing**: Officers tagged or towed 7 vehicles and identified 13 open garage doors. We notified these residents of the potential for becoming the target of criminal activity by leaving garages open through the night.
