

# MINUTES OF THE CITY OF VALLEY PARK BOARD OF ALDERMEN MEETING 7:00 PM – MARCH 20, 2023

#### APPROVAL OF AGENDA

Alderman Walker made a motion to approve the agenda. The motion was seconded by Alderman Reynolds. The motion passed on a voice vote.

#### APPROVAL OF MINUTES

Alderman Reynolds made a motion to approve the minutes from the February 21, 2023 Board of Alderman meeting. The motion was seconded by Alderman Halker. The motion passed on a voice vote.

### **CITIZEN COMMENTS**

Glenn Carlson (154 Wynstay Avenue) indicated he is not in favor of the new trash cans. Mr. Carlson stated that the City should resume streaming its meetings online, the City should allow residents to comment virtually, and the City should support a resident's submitted request to the Missouri State Auditor to audit the City's financial records.

City Attorney Tim Engelmeyer responded to Mr. Carlson indicating that the City's financial information is available for inspection at any time.

Alderman Walker responded to Mr. Carlson and said that the City is using ARPA funds for the new trash cans and that they will keep our employees from getting injured.

Ratification of Poll of the Board Vote authorizing the Mayor to Sign an Easement, on Behalf of the City, Granting Union Electric Company d/b/a Ameren Missouri Access to Install Electric Service Located Along a Roadway Commonly Known as Cal Hedrick Way in the Meramec Levee Recreation Park.

The Mayor and Board of Aldermen discussed the Application for Special Event submitted by CB's Chop House to have a tent in the parking lot of their restaurant for the St. Louis Cardinals opening day on March 30th from 11:00 am -5:00 pm. ## City Attorney's Report – Tim Engelmeyer

City Attorney Tim Engelmeyer stated that the Valley Park Municipal Court had a large docket recently and that it is clear that the police officers assigned to Valley Park are working.

### City Administrator's Report – Nathan Schauf

### **New City Hall Update**

City Administrator Nathan Schauf stated that the City is now under contract with LCS, LLC for the new City Hall at 55 Crescent. He stated that he would be inviting the contractor to attend the Board of Aldermen meeting in April.

### Meramec Levee Recreation Park Lighting

City Administrator Nathan Schauf presented updated information from Musco Lighting pertaining to 600-amp service at the park. There was discussion on this matter.

Alderman Bowen made a motion to accept the quote from Musco Lighting to install 800-amp service in the Meramec Levee Recreation Park. The motion was seconded by Alderman Reynolds. The motion passed on a roll call vote:

# Public Works Report – Gerald Martin

Public Works Director Gerald Martin informed the Mayor and Board of Aldermen that he and his employees have been working to repair sidewalks and have been performing asphalt repair in Ward 3 and will soon move to Ward 1 and Ward 2.

He also informed the Mayor and Board of Aldermen that summer sports leagues have begun playing at the Meramec Levee Recreation Park and Brignole Park.

He informed the Mayor and Board of Aldermen that he recently conducted a controlled burn with permission from the Valley Park Fire Protection District.

He informed the Mayor and Board of Aldermen that he is planning to discuss purchasing a new wood chipper during the next meeting of the Finance, Ways, and Means Committee.

Alderman White inquired about whether we have contracts in place with all groups who use our fields.

Alderman Bowen stated that he has seen our Public Works employees doing a lot of hard work the past couple of weeks and he asked Gerald Martin to let his employees know that he appreciates it.

### Community Development Report – Matt Roskowske

Community Development Director Matt Roskowske provided an update to the Mayor and Board of Aldermen regarding the number of code violation reports were generated last month and how many were abated without further action. He also provided an update regarding the number of building inspections were performed last month.

# Parks Report - Gil DeNormandie

Parks/Communication Coordinator Gil DeNormandie gave a brief report about the St. Louis County Parks Grant Commission and upcoming timeline for the next round of grants.

Alderman Young inquired about an update regarding the surface matting at the Brignole Park playgrounds. Gil DeNormandie indicated he would be getting in contact with contractors about providing quotes to install a new surface due to the issues with the current surface.

Alderman Young made a motion to solicit bids to fix the surface beneath the playgrounds at Brignole Park. Alderman Reynolds seconded the motion. The motion passed on a roll call vote:

Alderman White made a motion directing the City Administrator to create and distribute a mailer to inform voters about Proposition M which would appear on the April 4th ballot. The motion was seconded by Alderman Reynolds. The motion passed on a voice vote.
